- The reported transaction involves an award of restricted stock units under the M&T Bank Corporation 2009 Equity Incentive Compensation Plan. Each restricted stock unit represents a contingent right to receive one share of M&T Bank Corporation common stock upon vesting.
- (1) The restricted stock unit award includes a total of 13,147 shares. 1,314 shares of the restricted stock unit award will vest on January 31, 2014; an additional 2,630 shares will vest on January 30, 2015; an additional 3,944 shares will vest on January 29, 2016; and the remaining 5,259 shares will vest on January 3, 2017.
  - (2) The restricted stock units were granted under an equity incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the restricted stock units.

The restricted stock unit award includes a total of 5,746 shares. 1,723 shares of the restricted stock unit award will vest on January 30, 2015; an additional 1,724 shares will vest on January 29, 2016; and the remaining 2,299 shares will vest on January 31, 2017. This

(4) restricted stock unit award is intended to meet the requirements of the TARP Interim Final Rule's definition of "long-term restricted stock" as the award relates to the reporting person's performance during the period of time in 2012 that M&T continued to have an outstanding TARP obligation.

(5) Shares withheld for taxes upon the settlement in shares of restricted stock units previously granted to the reporting person.
