 - (1) Represents 3,790 shares of the issuer's common stock underlying restricted stock units granted to the reporting person under the issuer's Long-Term Incentive Plan. Each restricted stock unit will entitle the reporting person to receive one share of the issuer's common stock when that unit vests. The units will vest in three successive annual installments upon the reporting person's completion of each year of service with the issuer over the three-year period measured from the issue date of the units, subject to accelerated vesting under certain prescribed circumstances.
 - (2) Represents 5,119 shares of the issuer's common stock and 10,676 shares of the issuer's common stock underlying restricted stock units.
 - (3) Represents 536 shares of common stock of the issuer withheld by the issuer in satisfaction of the applicable withholding taxes on certain shares of common stock that became issuable on January 2, 2014 pursuant to the terms of the January 2, 2013 Restricted Stock Unit Issuance Agreement between the reporting person and the issuer.
