On December 31, 2011, the Issuer's Board of Directors approved a Debt Conversion Agreement which grants Mr. Howlett the right to (1) convert gross salary debt owed to him totaling \$415,657.03 into common stock of the Issuer as well as a warrant agreement to purchase one share for every two shares acquired. The actual expiration date is 3 years following the conversion date.
