**NOTICE TO SHAREHOLDERS**

**DELIBERATION OF INTEREST ON OWN CAPITAL**

Telefônica Brasil S.A. – (“Company”) announces to its shareholders that the Board of Directors, at its meeting held on December 19, 2016, deliberated, *ad referendum* of the General Shareholders’ Meeting, the credit of Interest on Own Capital (“IOC”), related to the fiscal year of 2016, in accordance with article 28 of the Company’s Bylaws, article 9 of the Law 9,249/95 and CVM’s Instruction No. 683/2012, in the gross amount of R\$ 604,145,000.00 (six hundred and four million, one hundred and forty-five thousand reais), subject to withholding tax of 15%, resulting in a net amount of R\$ 513,523,250.00 (five hundred and thirteen million, five hundred and twenty-three thousand, two hundred and fifty reais), based on the net profit shown in the balance sheet of November 30, 2016. The estimated value per share is described in the table below:

(\*) 10% higher than the amount granted to each common share, in accordance with article 7 of the Company’s Bylaws.

In accordance to the article 28 of the Company's Bylaws, such Interest on Own Capital will be charged to the mandatory minimum dividend for the fiscal year of 2016, *ad referendum* of the General Shareholders' Meeting to be held in 2017.

The credit of Interest on Own Capital will be made on individual basis for each shareholder, in accordance to the shareholder registry book position by the end of December 30, 2016. After this date, the shares will be considered as "ex-Interest on Own Capital". The payment of these proceeds will be carried out before the end of the fiscal year of 2017, in a date to be defined by the Company's Board.
