The shares of common stock of Apache are deemed to also represent certain preferred stock purchase rights ('Rights'). The Rights are not currently exercisable or separately tradable and presently are evidenced by certificates for shares of the common stock. Value attributable to such Rights, if any, is reflected in the market price of the common stock.

(1) Vesting on 11/18/2013 of restricted stock units pursuant to restricted stock unit award agreement under employer plan - data provided by plan administrator on 11/19/2013. Of these 4,000 shares, 2,400 shares (1,393 shares after tax withholding) will not be eligible for sale by the reporting person until such time as he retires or otherwise terminates employment with the company.
