(1) The Reporting Person first acquired shares of the Issuer's Common Stock as reported on Schedule 13D filed on April 23, 2003 and amended on November 17, 2003 by the controlling member of the Reporting Person. On April 13, 2007 the Reporting Person acquired 1,636,364 shares of the Issuer upon conversion of \$900,000 principal amount of the Issuer's promissory note due January 15, 2008. The controlling member of the Reporting Person holds 900,790 shares of the Issuer's Common Stock, as to which the Reporting Person disclaims beneficial ownership. The number of shares of the Issuer's Common Stock reported herein is adjusted to reflect the 25-to-1 reverse split of the Issuer's Common Stock which was effective on March 19, 2007.
