On May 2, 2018, Och-Ziff Capital Management Group LLC (the “Company”) issued a summary press release and a detailed earnings press release reporting of its financial results for the quarter ended March 31, 2018. On May 2, 2018, the Company announced that its Board of Directors declared a dividend for the first quarter of 2018 of \$0.02 per Class A share, representing Class A limited liability company interests of the Company.
