  - (1) These shares were sold by Kathleen Anne Farrell pursuant to a Rule 10b5-1 Sales Plan (the "Plan") entered into on September 13, 2012, which provided for the sale of shares of the issuer's Class A Common Stock. With the sales of the shares reported herein, the Plan has been completed and no future sales may occur pursuant to the Plan.
