(the "Company") was not able to timely file its Quarterly Report on Form 10-Q for the quarter ended June 30, 2013 because it was in the process of completing its analysis and evaluation of the impact of errors in prior period financial statement amounts related to the calculation and presentation of the income tax provision and the related deferred tax asset for the fourth quarter of 2012 and the first quarter of 2013. The Company was also in the process of completing its analysis of the implications of these corrections on its internal control over financial reporting. As a result, the Company was unable to file its Form 10-Q on a timely basis without unreasonable effort and expense.
