The number of derivative securities beneficially owned in column 9 includes 40.2453 dividend equivalent rights at \$52.18 per RSU credited to the reporting person's account on 01/06/10, and a de minimus adjustment of .4914 due to fractional rounding of the dividend equivalent rights.
