Between 2-10-06 and 3-31-06, the Reporting Person acquired 18 shares of Irwin Financial Corporation common stock under the Irwin Financial Corporation Employees' Stock Purchase Plan III (Plan) including shares acquired pursuant to a dividend reinvestment feature of the Plan. The Plan provides for the purchase of fractional shares. The number reported is the nearest whole number.

(2) Includes 4 additional shares acquired through participation in Irwin Financial Corporation Employees' Savings Plan (401K Plan). Shares noted are as of 4-6-06. The Plan provides for the purchase of fractional shares. The number reported is the nearest whole number.
