On June 26, 2015, the Board of Directors of AT&T Inc. increased the size of the Board from 12 to 13 members and elected Richard W. Fisher as a Director to fill the resulting vacancy. The Board also appointed Mr. Fisher to the Corporate Development and Finance Committee. Mr. Fisher will be compensated for his service as a non-employee Director as described beginning on page 11 of AT&T's 2015 Proxy Statement.

The Board has determined that Mr. Fisher is independent, based on the independence standards of the New York Stock Exchange and AT&T's additional independence standards, which are set forth on page 11 of AT&T's 2015 Proxy Statement.
