This Amendment No. 4 amends the Schedule 13D filed by Richard L. Scott ( Reporting Person ) on February 16, 2006 (the Schedule 13D), as amended on May 5, 2006, on May 15, 2006, and on July 31, 2007 with respect to shares of the Common Stock, no par value ( Common Stock ), of Key Technology, Inc., an Oregon corporation (the Issuer ). Capitalized terms used but not defined herein shall have the respective meanings ascribed to such terms in the Schedule 13D.

The following Items are hereby amended and restated in their entirety to read as follows:

**Item 5. Interest in Securities of the Issuer**

The 264,420 shares of the Common Stock owned by the Reporting Person constitute 4.82% of the outstanding Common Stock of the Issuer, based on the outstanding shares of Issuer Common Stock set forth in the Issuer's most recent Form 10-Q.

The Reporting Person has sole voting and dispositive power with respect to the Common Stock.
