 - (2) The options to purchase 66,176 shares of Common Stock of the Company were granted to Adrian M. The options vest and become exercisable in substantially equal installments on each of the first three anniversaries of the date of grant, which was March 9, 2016, subject to Mr. Jones continuing in service on the Company's board of directors through each such vesting date.
