- On December 22, 2004, the reporting person filed a Form 4 reporting the acquisition of 8,164 shares of restricted stock that were subject to performance-based vesting conditions that had not yet been achieved. As of December 22, 2004, the reporting person owned only 148,531 shares of common stock. Form 4's filed subsequently overstated the shares owned by the reporting person by these shares.
