BHP Billiton Limited announces that on 22 October 2007 it purchased 650,000 ordinary shares of BHP Billiton Plc at an average price of 1,770.87 pence per ordinary share.

Following the above transaction, BHP Billiton Plc holds 24,265,516 of its ordinary shares as treasury shares and BHP Billiton Limited holds 57,433,736 of the ordinary shares in BHP Billiton Plc, for a total of 81,699,252 shares. The total number of BHP Billiton Plc ordinary shares in issue (excluding shares held as treasury shares and shares held by BHP Billiton Limited) is 2,246,326,036.
