- (1) On December 18, 2007, the Reporting Person received a grant of 100,000 Restricted Stock Units ("RSUs") that represent a contingent right to receive one share of the Company's common stock. The RSUs were granted pursuant to the terms of the 2004 Stock Incentive Plan (the "Plan") and were previously reported as acquired on Table I of a Form 4 dated December 18, 2007. On June 18, 2008, in accordance with the terms of the RSU agreement, 1/8 of the shares vested and the Company withheld 4,213 RSUs at fair market value to pay the minimum tax obligations for the Reporting Person. On December 18, 2008, a second tranche of the shares vested and the Company withheld 182 RSUs at fair market value to pay the minimum tax obligations for the Reporting Person.
- (2) Also includes 150,000 RSUs granted pursuant to the Plan on November 6, 2008 that were previously reported as acquired on Table I on a Form 4/A dated November 10, 2008.
