  - (2) Forfeiture of restricted stock awards in connection with the director's retirement effective May 19, 2010. Repurchase right for remaining outstanding restricted stock awards caused to lapse on May 19, 2010.
  - (3) Upon the director's retirement effective May 19, 2010, the exercise period for all outstanding options was extended until the earlier of the original expiration date of such options or May 19, 2012.
