(the "Company"), Strategic Hotel Funding, L.L.C., the selling stockholders named therein, and Deutsche Bank Securities Inc. and Wachovia Capital Markets, LLC, as representatives of the underwriters (the "Underwriters"), on January 30, 2006, WHSHC, L.L.C. and W9/WHSHC, L.L.C. I, each of which is a WH Entity, sold to the Underwriters an aggregate of 5,935,452 shares of common stock, par value \$0.01 per share, of the Company, at an aggregate price of approximately \$113,000,000.
