- (1) Shares of restricted stock awarded under the Cree, Inc. 2004 Long-Term Incentive Compensation Plan. Shares awarded will vest on September 1, 2006 provided the recipient continues service until that date as a member of the Board of Directors of Cree, Inc. or as an employee of Cree, Inc. or a related "Employer" as defined in the Plan.
- (2) Of the 740,926 shares beneficially owned by Mr. von Arx, (1) 5,000 shares are held directly, (2) 202,592 shares are held directly in a revocable living trust, (3) 474,834 shares are held indirectly in a Grantor Retained Annuity Trust (GRAT), and (4) 58,500 shares are held indirectly in an individual retirement account (IRA).
- (3) The grant is subject to the condition that the shareholders approve certain amendments to the Cree, Inc. 2004 Long-Term Incentive Compensation Plan at the next annual meeting of shareholders to be held on November 3, 2005. The option will terminate if the amendments are not approved. The Option vests and becomes exercisable as to one-fourth of the shares on each of December 31, 2005, March 31, 2006, June 30, 2006 and September 30, 2006 or, if earlier, upon the election of directors at the 2006 Annual Meeting of Shareholders, provided the recipient continues service until said dates as a member of the Board of Directors of Cree, Inc. or as an employee of Cree, Inc. or a related "Employer" as defined in the Plan.
