The Reporting Persons undertake to provide, upon request by the Securities and Exchange Commission staff, the Issuer or a security holder of the Issuer, full information regarding the number of Shares sold at each price.
  - (2) These Shares are held by Tynan, LLC, a limited liability company of which William C. Crowley is the manager and a member.
  - (3) This price represents the approximate weighted average price per Share, of sales that were executed at prices ranging from \$233.25 to \$234.17 per Share.
