- (3) The restricted stock units were granted to the Reporting Person on February 25, 2014 and will vest on December 31, 2016 (contingent upon the Reporting Person's employment with the Issuer on the scheduled vesting date, except as provided for under the Issuer's 2016 Long-Term Incentive Plan).

The stock options were granted on February 25, 2014 and 5,042 have vested; the remaining 2,526 unvested stock options will vest and become exercisable on the third anniversary of the grant (contingent upon the Reporting Person's employment with the Issuer on the scheduled vesting date, except as provided for under the Issuer's 2016 Long-Term Incentive Plan).
- (6) The stock options were granted on February 20, 2013 and have vested.
- (7) The stock options were granted on February 28, 2012 and have vested.
- (8) The stock options were granted on March 2, 2011 and have vested.
