- (2) Represents shares transferred from P.G. Nicholas Trust M. No consideration was paid in connection with such allocation or distribution. The transfer of shares of Class B Common Stock to the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Contemporaneous with such transfer, Paul A. Bible, solely in his capacity as trustee to the Reporting Person, executed a joinder to, and thereby has become subject to the provisions of, the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following the transfer, the shares will remain shares of Class B Common Stock.
