This Amendment No. 3 (<u>"Amendment No. 3</u>") amends and supplements the statement on Schedule 13D filed with the Securities and Exchange Commission (the <u>"SEC"</u>) on June 3, 2015 (the <u>"Original Schedule 13D"</u>), as amended by Amendment No. 1 filed with the SEC on September 29, 2015 (<u>"Amendment No. 1"</u>) and by Amendment No. 2 filed with the SEC on October 27, 2015 (<u>"Amendment No. 2</u>," and the Original Schedule 13D as amended hereby and by Amendment No. 1 and Amendment No. 2, the <u>"Schedule 13D"</u>) with respect to the common stock, par value \$0.001 per share (the <u>"Shares"</u>), of JAKKS Pacific, Inc., a Delaware corporation (the <u>"Iss</u>uer"). Capitalized terms used herein and not otherwise defined in this Amendment No. 3 have the meanings set forth in the Schedule 13D. This Amendment No. 3 amends Items 3 and 5 as set forth below.

Item 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Item 3 of the Schedule 13D is hereby amended and restated in its entirety as follows:

Funds for the purchase of the Shares by Oasis II Fund reported herein were derived from general working capital and margin account borrowings made in the ordinary course of business. In such instances, the positions held in the margin accounts are pledged as collateral security for the repayment of debit balances in the account, which may exist from time to time. Since other securities are held in the margin accounts, it is not possible to determine the amounts, if any, of margin used to purchase the Shares reported herein. A total of \$9,396,458 was paid to acquire the 1,352,820 Shares reported herein. A total of \$10,743,288 was paid to acquire the \$11,160,000 principal amount of 4.25% Convertible Senior Notes due 2018 (the "2018 Convertible Senior Notes") reported herein. A total of \$9,559,859 was paid to acquire the \$10,250,000 principal amount of 4.875% Convertible Senior Notes due 2020 (together with the 2018 Convertible Senior Notes, the "Convertible Senior Notes") reported herein.

Item 5 INTEREST IN SECURITIES OF THE ISSUER

Paragraphs (a) and (c) of Item 5 of the Schedule 13D are hereby amended and restated in their entirety as follows:

- See rows (11) and (13) of the cover pages hereto for the aggregate number of Shares and percentages of the Shares beneficially owned by each of the Reporting Persons. The percentages used herein are calculated based upon 20,002,003 Shares reported by the Issuer to be outstanding as of November 9, 2016, as disclosed in the Issuer's Quarterly Report for the period ended September 30, 2016, filed on Form 10-Q on November 9, 2016.
- The transactions in the Shares by Oasis II Fund within the past sixty days, which were all in the open market, are set forth in <u>Schedule B</u>, and are incorporated herein by reference. The other Reporting Persons did not enter into any transactions in the Shares within the past sixty days.
