(the <u>Issuer</u>). Capitalized terms used but not otherwise defined in this Twenty-Fourth Amendment have the meanings ascribed to such terms in the Schedule 13D, as amended.

<u>Item 2</u>. <u>Identity and Background</u>.

The aggregate amount of funds required to purchase the 49,000,000 L Shares purchased by CGT since the filing of Amendment No. 23 to the Schedule 13D filed by the Reporting Persons on March 14, 2006 (the <u>Twenty-Third Amendment</u>) was U.S.\$54,126,475. The funds used to purchase these shares were obtained from the working capital of CGT.
