4. Summary of Material Change

Edgar Filing: Glencairn Gold CORP - Form 6-K

Glencairn Gold Corporation (the Company) announced that it has priced its previously announced financing. Glencairn will issue 15.8 million Units at a price of \$0.38 per unit for gross proceeds of \$6,004,000. Subsequent to this announcement, the Company closed the financing on December 22, 2005.

5. Full Description of Material Change

The Company announced that it has priced its previously announced financing. Glencairn will issue 15.8 million Units at a price of \$0.38 per unit for gross proceeds of \$6,004,000. Each unit will be comprised of one common share and one-half of one common share purchase warrant with each whole common share purchase warrant exercisable for 12 months from closing at a price of \$0.55. The financing is being offered through a syndicate of agents led by Orion Securities Inc. and including Dundee Securities Corporation and Haywood Securities Inc.

The offering is scheduled to close on or about December 22, 2005, and is subject to certain conditions including, but not limited to, receipt of all necessary approvals including approval of the Toronto Stock Exchange and Canadian securities regulatory authorities.

Subsequent to this announcement, the Company closed the financing on December 22, 2005.
