Revenues for the three and nine month periods ended September 30, 2002 declined 24% and 39% ,respectively, when compared to the corresponding 2001 periods. Total revenues for the three and nine month periods ended September 30, 2002 were \$283,478 and \$629,072, respectively, compared to \$374,722 and \$1,036,553 for the corresponding 2001 periods. The registrant reported a net loss of \$549,810 for the third quarter 2002 compared to a net loss of \$145,288 for the third quarter of 2001. The net loss for the first nine months of 2002 was \$1,198,634 compared to a net loss of \$594,995 for the 2001 period.
