#### Item 1. Security and Issuer

This statement relates to shares of Class B Voting Common Stock (the "Stock") of **Reading International, Inc.** (the "Issuer"). The principal executive office of the Issuer is located at **550 S. Hope St., Suite 1825, Los Angeles, CA 090071..**

#### Item 2. Identity and Background

The persons filing this statement and the persons enumerated in Instruction C of Schedule 13D and, where applicable, their respective places of organization, general partners, directors, executive officers and controlling persons, and the information regarding them, are as follows:

(a) **Lawndale Capital Management, LLC, a California limited liability company ("LCM"), Diamond A. Partners, L.P., a California limited partnership ("DAP"), and Andrew E. Shapiro ("Shapiro")** (collectively, the "Filers").

**DAP is filing this statement jointly with the other Filers, but not as a member of a group and expressly disclaims membership in a group.**

(b) The business address of the Filers is **One Sansome Street, Suite 3900, San Francisco, CA 94104.**

(c) Present principal occupation or employment of the Filers and the name, principal business and address of any corporation or other organization in which such employment is conducted:  
**LCM is the investment adviser to and the general partner of DAP, which is an investment limited partnership. Shapiro is the sole manager of LCM.**

(d) During the last five years, none of the Filers has been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

(e) During the last five years, none of the Filers was a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) **Shapiro is a citizen of the United States of America.**

Item 4. Purpose of Transaction

The Filers ("Lawndale") have been and may continue to be in contact with Reading International, Inc.'s ("Reading") management, members of Reading's Board of Directors, other significant shareholders and others regarding alternatives that Reading could employ to maximize shareholder value.

Lawndale believes that the public market value of Reading, currently trading below Reading's tangible book value, is undervalued by not adequately reflecting the value of Reading's underlying business and assets, the potential value from its new international movie theater and real estate development initiatives, and expected synergies from the recent consolidation merger with Reading's affiliates.

Lawndale acquired the Stock solely for investment purposes, and Lawndale may from time to time buy or sell the Stock at its discretion.

Item 5. Interest in Securities of the Issuer

The beneficial ownership of the Stock by each Filer at the date hereof is reflected on that Filer's cover page.

The Filers effected the following transactions in the Stock through the American Stock Exchange on the dates indicated, and such transactions are the only transactions in the Stock by the Filers since **January 18, 2002**:
