These shares were contributed by Mr. Connell to the Radnor Blind Trust, John F. McGill, Jr, Trustee. The Trustee has sole voting and dispositive power over these shares. Mr. Connell is the grantor/settlor and the sole beneficiary of the Trust, and retains the power to (1) revoke the Trust at any time. No consideration or value was exchanged in connection with the contribution of these shares to the Trust. Under SEC Rule 16a-8(b)(4), the Trust is now the only person required to file under Section 16 with respect to these shares, although Mr. Connell remains a beneficial owner of these shares under the SEC's rules under Section 13d.
