As of February 10, 2006, Select and Select Offshore are the beneficial owners of 4,286,808 shares of Common Stock of HCC Insurance Holdings, Inc. ("Common Stock"), for a total beneficial ownership of 4.05% of the outstanding shares of Common Stock.
