ATTACHMENT A

As of February 10, 2006, Select and Select Offshore are the beneficial owners of 6,233,345 shares of Common Stock of VCA Antech, Inc. ("Common Stock"), for a total beneficial ownership of 7.54% of the outstanding shares of Common Stock.
