The securities to be registered hereby are the common stock, par value \$0.001 per share (the "Common Stock"), the warrants, exercisable for Common Stock at an exercise price of \$7.00 per share (the "Warrants") and units, each consisting of one share of Common Stock and one Warrant (the "Units") of GHL Acquisition Corp. ("GHL Acquisition"). GHL Acquisition will be renamed Iridium Communications Inc. immediately following the closing of its acquisition of Iridium Holdings LLC.
