Will I see any changes in the products and services I get from Aetna as a result of this acquisition?

Your benefits are not changing. Over time as we combine our companies, we expect to offer new health and wellness-related services that make access to affordable, high quality care more convenient. We will do this by building on our combined capabilities. We will inform you of these new offerings in advance so that you can decide how to take advantage of them.

Do I now have to fill all my prescriptions at a CVS pharmacy?

Your prescription benefits are not changing. You should continue filling your prescriptions as you do today. Express Scripts is your Pharmacy Benefit Manager and this is not changing.

I'm a provider; will my primary point of contact or my reimbursement change as a result of this transaction?

Aetna and CVS Health will continue to operate in all respects as two separate companies until the transaction closes, which we expect to happen in the second half of 2018. We will keep you informed of any changes as the closing approaches.
