This prospectus supplement supplements information contained in the prospectus dated June 21, 2006 of Informatica Corporation, as previously supplemented by prospectus supplement dated June 27, 2006 and prospectus supplement No. 2 dated July 21, 2006 (as so supplemented and amended, the prospectus), relating to the offer and sale from time to time by certain selling security holders of our 3% Convertible Senior Notes due 2026, which are referred to as the notes, and the common stock issuable upon conversion of the notes. We will not receive any proceeds from the sale of the notes or the common stock issuable upon conversion of the notes by the selling security holders.

This prospectus supplement should be read in conjunction with, and may not be delivered or utilized without, the prospectus. This prospectus supplement is qualified by reference to the prospectus, except to the extent that the information in this prospectus supplement supersedes the information contained in the prospectus.
