## TERMINATION OF REGISTRATION

This Post-Effective Amendment No. 1 relates to the Registration Statement on Form S-8 (Registration No. 333-89037) of The ServiceMaster Company (ServiceMaster).

ServiceMaster, ServiceMaster Global Holdings, Inc., a Delaware corporation (formerly known as CDRSVM Topco, Inc.), and CDRSVM Acquisition Co., Inc.
