Represents a grant of 350,000 shares of restricted stock received by A. R. Sanchez, Jr. from Sanchez Energy Corporation (the "Issuer"), which was previously reported on the Form 4 filed on January 11, 2012. At the recommendation of the Issuer's President and Chief Executive Officer, Antonio R. Sanchez, III, and with the consent of A. R. Sanchez, Jr., the Issuer's board of directors approved the rescission of the award to A. R. Sanchez, Jr. in its entirety. As a result, A. R. Sanchez, Jr. no longer holds the 350,000 shares of restricted stock of which he was previously the sole record owner.

(1) These shares are owned directly by Sanchez Energy Partners I, LP ("SEP I"). SEP I is controlled by its general partner, SEP Management I, LLC, which is a wholly-owned subsidiary of Sanchez Oil & Gas Corporation ("SOG"). SOG is managed by A. R. Sanchez, Jr. and Antonio R. Sanchez, III. Thus, A. R. Sanchez, Jr. may be deemed to share voting and dispositive power over the shares held by SEP I. A. R. Sanchez, Jr. disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein, and the inclusion of these securities in this report shall not be deemed an admission of beneficial ownership by A. R. Sanchez, Jr. of the reported securities for purposes of Section 16 or any other purpose.
