The holders of 101,212,281 shares of Class A common stock, or approximately 87.2% of the eligible voting shares, were represented at the meeting in person or by proxy.

All nominees for election to the Board were elected for a term that will continue until the next annual meeting of stockholders or until the director s successor has been duly elected and qualified (or the director s earlier resignation, death or removal).
