- (1) Balance includes 26 shares acquired on 03/10/2007, 24 shares on 06/11/2007, 24 shares on 09/10/2007 and 20 shares on 12/10/2007 through the automatic dividend reinvestment feature of Exelon plans.  
Shares held as of 12/31/2007 in a multi-fund 401(k) Plan to be settled in cash upon the reporting person's termination of employment for any reason on a 1:1 basis. Shares are acquired through regular periodic contributions, company matching contributions, and the automatic reinvestment of dividends.
- (3) Performance Shares awarded pursuant to the Exelon Long Term Incentive Plan. 1/3 of the shares awarded vested immediately upon receipt. The remaining shares vest in 1/3 increments on each of the first and second anniversaries of the award date. Under certain circumstances some or all of the vested shares may be settled in cash on a 1 for 1 basis based on the cash value of the underlying stock on the date of vesting.
- (4) Balance includes 184 shares acquired on 03/10/2007, 168 shares on 06/11/2007, 167 shares on 09/10/2007 and 143 shares on 12/10/2007 through the automatic dividend reinvestment feature of Exelon plans.

Shares are acquired through regular periodic contributions, company matching contributions, and the automatic reinvestment of dividends.
