 - (1) On July 13, 2012, Terrence C. Anderson, as settlor of the Terry C. Anderson 2012 GRAT (the "GRAT"), received from the GRAT 374,740 shares of the Common Stock, par value \$0.01 per share (the "Common Stock"), of the Issuer, which shares had previously been transferred by Mr. Anderson to the GRAT, in exchange for assets of equal value. As a result, these 374,740 shares of the Common Stock are now beneficially directly owned by Mr. Anderson. Currently, the GRAT beneficially owns none of the Common Stock.
 - (2) For purposes of the transaction described herein, the price was determined by calculating the average of the high (\$3.19) and low (\$3.13) trading prices on July 13, 2012, the effective day of the transaction.
