On April 19, 2013, July 19, 2013 and October 18, 2013, dividends on these shares were paid and automatically reinvested by the Compensation Plan Trust in additional Class A Common Stock for the benefit of Mr. Myers in the amounts of 12.9191 shares, 13.0299 shares and 14.4804 shares,

- Mr. Myers is the direct beneficial owner of 131,950 shares of Class A Common Stock, including the 90,000 restricted shares referenced
