The shares of phantom stock relate to director compensation that the reporting person has elected to defer under the Cleco Corporation (1) Deferred Compensation Plan (the "Plan"). Each share of phantom stock is the economic equivalent of one share of Cleco Corporation common stock.

The reporting person transferred holdings from the Company's phantom stock units held within the Cleco Corporation Deferred (2) Compensation Plan (the "Plan") to other investments within the Plan to levelize certain payments to be made under the Plan upon retirement from the Board of Directors.

Includes 5,273 shares of phantom stock (not subject to restrictions) related to dividend reinvestment on shares of phantom stock and (3) phantom stock awarded pursuant to the terms and provisions of the Plan.
