This Schedule 13G is being jointly filed by Citadel Advisors LLC ("Citadel Advisors"), Citadel Advisors Holdings LP ("CAH"), Citadel GP LLC ("CGP") and Mr. Kenneth Griffin (collectively with Citadel Advisors, CAH and CGP, the "Reporting Persons") with respect to shares of common stock (and options to purchase common stock) of the above-named issuer owned by Citadel Multi-Strategy Equities Master Fund Ltd., a Cayman Islands limited company ("CM"), Ashler Capital Master Fund Ltd., a Cayman Islands limited company ("AC"), Citadel Securities LLC, a Delaware limited liability company ("Citadel Securities") and CRBU Holdings LLC, a Delaware limited liability company ("CRBU").

Mr. Griffin is the President and Chief Executive Officer of CGP, and owns a controlling interest in CGP and CSGP.
