**Item 2.02, "Results of Operations and Financial Condition"**

On October 25, 2013, Moody's Corporation (the "Registrant") announced its financial results for the quarter ended September 30, 2013. A copy of the press release containing the announcement is included as Exhibit 99.1.

In addition to financial results determined in accordance with generally accepted accounting principles (GAAP) that are included in the press release, the press release also includes a non-GAAP EPS financial measure (as defined under Regulation G of the Securities Exchange Act of 1934, as amended (the "Exchange Act")) and a reconciliation of that number to GAAP.

As stated in the press release, as of October 25, 2013, non-GAAP Earnings Per Share guidance for fiscal year 2013 is now \$3.51 to \$3.57, excluding the impact of a litigation settlement charge; Earnings Per Share guidance for fiscal year 2013 is \$3.37 to \$3.43 on a GAAP basis, including the \$0.14 per share impact of the litigation settlement charge. The foregoing non-GAAP financial measure should be considered in addition to, not as a substitute for or superior to, EPS prepared in accordance with GAAP as more fully discussed in the Registrant's financial statements and filings with the Securities and Exchange Commission.
