- (a) The annual meeting of shareholders of New York Community Bancorp, Inc. was held on June 4, 2014, with 397,490,227, or approximately 89.80%, of the outstanding common shares entitled to vote represented in person or by proxy.
- (b) The matters considered and voted on by the Company's shareholders at the annual meeting, and the vote itself, were as follows:

1. The following individuals were elected as directors, each for a three-year term, by the following vote:

2. The appointment of KPMG LLP as the independent registered public accounting firm for the fiscal year ending December 31, 2014 was ratified by the following vote:
