Company sees accelerating Capacity Build-ups throughout its customer base

REHOVOT, Israel, June 9, 2010 - Nova Measuring Instruments Ltd. The Company further reported that this standalone order is part of a multimillion dollar deal which also includes multiple integrated metrology optical CD systems. The majority of the systems will be shipped during the second and third quarters of this year.
