(1) 5,555 shares were issued to Doris F. Fisher, the reporting person's spouse, in settlement of the stock units originally granted to her on June 3, 2008. Each stock unit represented the right to receive one share of Gap Inc. common stock. The reporting person beneficially owns the shares issued to Doris F. Fisher as community property.

(2) 118 shares were issued in settlement of 118 dividend equivalent rights which accrued on May 19, 2009 and were immediately vested on the above-referenced stock units originally granted to Doris F.
