- (1) This option, representing a right to purchase 61,158 shares of Class A Common Stock, became exercisable as to 25% of the shares on May 3, 2008. Thereafter, the remaining 75% of the option vests in equal annual installments over three years.
- (2) This option, representing a right to purchase 350,000 shares of Class A Common Stock, became exercisable as to 25% of the shares on June 8, 2008. Thereafter, the remaining 75% of the option vests in equal monthly installments over three years.
- (3) This option, representing a right to purchase 50,000 shares of Class A Common Stock, became exercisable as to 25% of the shares on June 1, 2010. Thereafter, the remaining 75% of the option vests in equal monthly installments over three years.
