- (1) I will retire as a director of Questar in May of 2005 and receive a cash payment in June for the value of my phantom stock units as of May 31, 2005.
- (2) The phantom stock units were awarded to me as partial compensation for my services as a director and were granted under the terms of Questar's Long-term Stock Incentive Plan. The units are restricted, but will vest on an accelerated basis when I retire in May of 2005 as a director of Questar. I will receive a cash payment for the units in June of 2005. I defer my director's fees and these fees are accounted for in phantom stock units, which also are credited with "dividends." The total includes 15,261.9552 phantom stock units under Questar's

formal Deferred Compensation Plans for Directors and 2,734.3860 phantom stock units granted under Questar's Long-Term Incentive Plan.
