RSUs vest one year after the grant date and, on the settlement date, are convertible into shares of common stock on a one-for-one basis. The settlement date is either three years after the date of grant, for RSUs granted before July 2005, and six months after the reporting person ceases to be a director of Sara Lee, for other RSUs.
