Further, the Registrant anticipates reporting net operating losses of \$9,047 and \$147,699 for the three and nine months ended September 30, 2013, respectively, as opposed to net operating losses of \$73,738 and \$249,881 for the same quarters of 2012. In addition, the Registrant anticipates reporting a total comprehensive loss of

\$23,913 and total comprehensive income of \$59,818 for the three and nine months ended September 30, 2013, respectively, contrasting to total comprehensive loss of \$66,646 and total comprehensive income of \$1,546,129 for the same periods of 2012.
